Application for Letter of permission for functioning of Bhargva Homoeopathic Medical College At& Post, Vidyagram, , Ta, Borsad, dist. Anand -388560-Gujarat, UG (BHMS) course with intake capacity of 100 seats, for the academic year 2022-2023 regarding

Sir.

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020 and its relevant regulations. As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 Performa were examined by the Medical Assessment and Rating Board.

It has been observed that the Average bed occupancy of the college for last one year is 16%. Total no of patients in OPD Last calendar year is 124. Although due to covid situation IPD/OPD status are not considered for permission process, being an educational Institute, this needs to be tremendously enhanced considering the clinical training facilities to be imparted to the students. You are required to take necessary measures for improvement of OPD/IPD and the status and the same shall be apprised to MARBH within 3 months from the date of issue of this letter.

- After considering the provisions of NCH Act, 2020 and its relevant regulations, permission of the Medical Assessment and Rating Board is issued to, Bhargva Homoeopathic Medical College At & Post, vidyagram, Ta, Borsad, Dist. Anand for UG (BHMS) course with intake capacity of 100 seats for the academic year 2022-23.
- All admission in undergraduate (BHMS) course shall be through National Eligibility Entrance Test (NEET), Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed in such cases. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by the respective Counseling Authority of State / UT as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT.

College need to fulfill all requirements as per NCH Act 2020and relevant regulations. All shortfalls shall be rectified within period of one month from 30 days of issue of permission of this letter

- The permission of the college stands withdrawn if the college fails to comply with the 4 aforesaid direction of the Central Government for All India quota or the student admitted thereunder.
- The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.
