Sub: Application for Letter of permission for functioning of Bhargava Homoeopathic Medical College, Vidyagram, At & Post-Dahemi, Ta-Borsad, Dist. Anand, Gujarat with intake capacity of 100 seats in UG (BHMS) Course for the academic year 2023-2024 regarding.

Bhargava Homoeopathic Medical College, Vidyagram, At & Post-Dahemi, Ta-Borsad, Dist. Anand, Gujarat is functional since 2018 and has applied for permission for sanction of 100 seats in BHMS for the academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under NCH Act 2020. On careful examination of the application, the Medical Assessment and Rating Board has observed the following shortfalls as per MSR requirements.

## A. Teaching Faculty and Infrastructure:

- AV facility is not available in one lecture hall & the seminar hall. i.
- Adequate seating, lighting & fan arrangements were not present in the seminar hall. ii.
- A separate HOD room is not present in the departments. No separate chairs & tables for iii. the faculties in the respective departments.
- No separate Department room is present for Department of Repertory. Modern software iv. like RADAR & ISIS are not present in the department. One computer is not functional in the Computer Lab of the Department.

#### B. Hospital Facility:

- X-Ray machine seems to be non-functional & there is no dark room & space for storing films & chemicals. Ultrasound machine is not present in the hospital.
- There is no finding of investigation documented in IPD & OPD case records.
- Both OPD & IPD case records are incomplete in many aspects like demographic records, iii. repertorisation etc.

#### C. Hospital Staff:

• The physical presence of Anesthesiologist, Obstetrician, Radiologist, Surgeon, Physiotherapist, Gynecologist, Physician, Ophthalmologist, Pediatrician, Dietician, Yoga Expert & Dentist could not be verified at the time of inspection. Therefore, college is required to submit the appointment order, attendance and acquittance the above mentioned hospital staff.

Considering the above observations, and facilities available, Medical Assessment and Rating Board has decided to issue Conditional permission to Bhargava Homoeopathic Medical College, Vidyagram, At & Post-Dahemi, Ta-Borsad, Dist. Anand, Gujarat-388560 with intake capacity of 100 seats in UG (BHMS) Course for the academic year 2023-24.

The above shortfalls observed in your College shall be rectified within a period of 15 days or before counselling for admissions initiates, whichever is earlier, and the compliance report shall be submitted to the MARBH, failing which the conditional permission issued will be withdrawn without further notice.

OPD and IPD attendance shall be as per the regulations and minimum number of 120 cases are to be registered in the OPD register per day being a UG Institute, and all cases shall be made available in the medical records room for the academic purpose for students and follow up purpose for the patients.

It is highly essential that all cases registered in the Medical College be recorded with complete demographic details of the patients essentially contact details, postal address, and diagnosis as per ICD criteria of diseases.

For recording of OP case records, a short case recording proforma shall be followed. For the Chronic cases attended in the Hospital, irrespective of OP or IP, detailed case recording format shall be followed with entire follow ups recorded on the case records. Cases attended in Community Health Care activities also shall be kept well documented for ongoing academic and follow up purposes.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
