Sir,

Application for Letter of Permission for functioning of Bhargava Homoeopathic Medical College and Hospital, functional since 2018 with intake capacity of 100 seats in UG for BHMS course have been required for the A.Y. 2024-25. The College has submitted the Part I information in which the entire functional profile has been narrated. Medical Assessment and Rating Board has examined the profile of the college as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under the NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfalls.

a) Miscellaneous

- Aadhar enabled biometric attendance system is installed but not functional.
- Forms 16 are not from Traces portal.

b) Teaching staff

- There is no Assistant Professor in Department of FMT.
- There is no Professor in Department of Community Medicine.

c) Hospital OPD and IPD

- Case records should be maintained with demographic details of the patient such as Name, Age Sex, Address, Phone numbers with complete case analysis, evaluation and repertorisation. These documents and follow up attendance of the patient shall be made available in the Medical Record Room for academic purpose of students.

Considering the above observations and facilities available, MARBH has decided to issue **Conditional Permission for functioning of Bhargava Homoeopathic Medical College and Hospital, with intake capacity of 100 seats in BHMS course for the A.Y. 2024-25.**


All deficiencies noticed shall be rectified within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made from NEET qualified candidates only. It is further informed m 15% of seats of the permitted intake capacity of 100 U.G Seats shall be treated as All India Quota. Counseling for seats under All India quota shall be conducted by respective Counseling Authority of State/UT Govt as designated by Central

Government/NCH for the A.Y 2024-25 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn or denied in the subsequent year if college found deficient in compliance to MSR 2013 anytime during the academic year.
